Section 1

1.1 Introduction / Executive Summary

Clyde Gateway comprises Clyde Gateway URC (CGURC) a charity limited by guarantee and Clyde Gateway Developments Limited (CGDL) a trading subsidiary limited by shares. Procurement is undertaken by both companies and both are referred to in this document. This report covers the financial year 2022/23.

The overarching purpose of Clyde Gateway's Procurement Strategy is to support the delivery of high-quality projects that offer value for money, and in a sustainable way, taking account of best practice and Scottish Government and EU procurement legislation.

Over the period of the report, Clyde Gateway made 12 contract awards via Public Contracts Scotland (PCS). Of these contracts:

- Six were professional Service contracts of which three were above £50,000.
- Six were works contracts of which one was over £2m.
- One procurement was over the works threshold of £5.336m including VAT/£4.447m excluding VAT.

Much of Clyde Gateway's activity is in construction, and construction related activity, and all awards were within these categories. The works contracts over £2m comprised of:

 Clyde Gateway East – Three High Value Manufacturing Industrial Units - £7.4 m (excluding VAT)

Clyde Gateway also utilised two frameworks to let Professional Service contracts. These frameworks and associated contract values are:

- Crown Commercial Service Framework Contract value of £1,280,000
- Scotland Excel Furniture Framework Contract value of £31,000

Over the period of the report Clyde Gateway maintained procurement to a high standard in line with its strategy and regeneration objectives.

1.2 Regulated Procurements

Over the financial year 2022/23 six regulated procurements were undertaken across CGURC and CGDL - Note, these regulated procurements are not specific to PCS and include contracts let through frameworks and other forms of procurement. These regulated procurements were contracts where the value was over £50,000 for goods and services contracts and £2 million for works contracts. Within



this number five were services contracts worth over £50,000 and one was a construction contract worth over £2 million.

The total value of all regulated procurement awards was £8,926,995. The total value of all non-regulated procurements was £3,369,744.

1.3 Compliance

Over the period 2022/23 all six regulated procurements were classified as compliant.

No regulated procurements were classified as non-compliant.

There were no procurement challenges. That is a procurement or legal challenge from a supplier requiring Clyde Gateway to reconsider or set aside a contract.

1.4 Community Benefit

Clyde Gateway is committed to Delivering Best Practice community benefits regardless of the scope and value of the procurement.

Over the period of the report highlights include one job filled by a Priority Group, one apprenticeship filled by a Priority Group and two work placements provided for Priority Groups. Much of Clyde Gateway's work is directly influenced by our communities and through Community Benefit four organisations and 495 individuals have been supported directly.

1.5 Supported Businesses

The volume of Clyde Gateway's procurement and contracts in construction, and construction related activity, has limited the capacity of Clyde Gateway to be contracted with supported businesses in regulated procurements

No supported businesses were awarded contracts over the reporting period.

1.6 Forward View

Over the period of 2023/24 Clyde Gateway will seek to maintain its procurement to a high standard in regulated and non-regulated procurement.



At the time of this report around 19 procurements with a value of £11m are anticipated during the 2023/24 financial year across construction, and construction related activities, but this will be dependent on grant awards received, including potential awards from the UK Levelling Up Fund, which may materially change the procurement scope.

Efforts to secure awards to supported businesses will be further considered.

Clyde Gateway pays valid, undisputed invoices within 30 days from receipt. The percentage data within the return does not fully take account of invalid invoices including credit notes, signed contracts to authorise PO's or invoices received late. Measures to accurately quantify payment performance were implemented during the 2021/22 reporting period. As a result, Clyde Gateway's payment performance improved by 13% during the 22/23 period.
